C. In addition to the cost of food and novelties used for ODS staff, TCODS is charged \$6.00 per night for each person staying overnight in camp. (The TCODS cost for each staff person at ODS is a minimum of \$110.00. We know it's strange to be asking volunteers to donate toward their stay, but the money to pay for the cost of each staff person must come from somewhere.)

Serving as staff at ODS does not require a donation to cover the costs. However, we hope that each person can contribute something toward the cost of his/her stay. **All donations are graciously accepted!**

(If possible it would be an incredible help for each staff person to help unload the U-Haul etc. at Moses & Zippy's home at the end of the 2nd week after camp cleanup.)

Counselors & students are asked to NOT bring phones; so if you DO bring a phone please have it locked up. Valuables can be locked up in a secure room in the lodge.

D. MAJOR RULES:

1. **Outside of a doctor's care, there are absolutely NO drugs or alcohol allowed in camp.**
2. **No guns, pets or surfboards are allowed in camp.**
3. **Sixth grade students and all others will NOT be harmed in any way by anyone including staff.**
4. **I will abide by the "Outdoor School Rules For Adults."**
