**D. Parent/Guardian:** There is a \$35.00 fee per counselor. This will partially help pay the actual cost of \$100.00+ that it costs per high school student. Please consider donating more than the \$35.00 fee as it's difficult for us to meet our expenses.

ODS cannot provide transportation for high school students. They must either be driven into camp by someone else or drive in on their own. Once belongings are unloaded and cars are parked, students are not allowed to get back into vehicles until camp is over on Friday.

**Students must be in camp ready to begin training by 1:00 PM Saturday before the week they will counsel. They need to remain in camp until 4:00 PM Friday and may be picked up soon after 4:00 PM. Please arrange for a pick up no later than 4:30 PM.**

**Students need a "sack supper" for the Saturday evening meal. No other food or drink should be brought into camp!**

#### MAJOR RULES:

1. Outside of a doctor's care, there are absolutely **NO** drugs, alcohol, or tobacco allowed in camp.
2. High school students must each remain in his/her cabin area at night with the sixth graders each is responsible for.
3. Sixth grade students will **NOT** be harmed in any way by high school students.

"I understand that should my son/daughter be found in violation of a major rule at camp, the high school administration and I will be notified, and my son/daughter will need to leave camp immediately. I give permission for my child to attend ODS as a counselor."
